**Liability Release**

Acknowledgment of Assumption of Risk, Release and Indemnity Agreement: The Club shall not be liable for any damages arising from injuries or damages sustained by Guests, Adults/Parent/Guardians, or Participants, including minor children and any guests, in, on or about the premises of the Club. Athletic or fitness programs should not be undertaken without approval of a physician. Physical exercise can cause severe injuries or even death. Each person, by using the Club and its facilities, represents that she or he is in good physical condition and is able to use the equipment, facilities and services provided and accepts these risks and assumes full responsibility for any injuries or damages to herself or himself, to any minor children or guests in, on or about Club premises, and agrees to abide by all rules and regulations currently in effect and posted in the Club or which may be promulgated by the staff relating to the operation and use of Club equipment, facilities and services. Each person, including children, who uses the Club, hereby and forever releases and discharges the Club, its owners, employees and agents from any and all claims, demands, damages, rights or causes of action present or future, whether the same be known or unknown, anticipated or unanticipated, resulting from or arising out of the use or intended use of the facilities and equipment thereof and agrees to pay all attorneys fees and other expenses incurred by the Club in connection therewith. Adult/Parent/Guardian represents and warrants that s/he is authorized to enter into this agreement on behalf of all minor participants and all other children who will use the Club under this Agreement.

**Payment:** The Responsible Party listed above shall be billed and shall pay all fees shown herein and is also liable for payment in full for any entry fees, court fees, program fees, and activity fees in advance of usage for him/herself and others listed below. In the event that the Responsible Party fails to pay any amounts owed prior to usage, all Adults listed shall be jointly and severally responsible for payment of all amounts due under this Contract and authorize Club usage by all minors listed herein. All fees and costs are due, and shall be paid, in advance of usage. Balances which are over 30 days past due are subject to a 1.5% monthly service fee (Annual rate is 19.6%). In addition to other rights the Club shall have, Club reserves the right to: 1) Collect the current and past due balance in any subsequent month; 2) Collect the entire balance due for any fee, service or program immediately; 3) At any time, including immediately, suspend all Club Usage by Guest/Participant; and 4) Recover from Responsible Party any and all outstanding balances, penalties, collection fees, attorney fees, usage fees, and court costs as allowed by law.

**Make-up Policy**

*Kids Classes:* All players must attend the actual class (level, day and time) for which they register.

In order to make sure we have adequate numbers of coaches and courts available and to avoid overcrowding of classes, players may attend a make-up class at the same level with 24 hour notice AND PRE-APPROVAL from the Junior Tennis Program Director. A maximum of 2 makeup classes per session will be allowed. Absolutely no drop-in make-ups will be permitted.

*Adult Classes:* All players must attend the actual class (level, day and time) for which they register.

In order to make sure we have adequate numbers of coaches and courts available and to avoid overcrowding of classes, players may attend a make-up class at the same level with 24 hour notice AND PRE-APPROVAL from their Pro Instructor. A maximum of 2 makeup classes per session will be allowed. Absolutely no drop-in make-ups will be permitted.

**Refund Policy:** There will be no refunds or credits for missed classes.

**Photography Release:** Participants hereby agree to have their picture taken and maintained by the Club.

Guest/Participant agrees that Images (photos or videos) may be used in any medium including but not limited to print and electronic (e.g., Internet) for purposes of advertising, trade, display, exhibition or editorial use. Guest/Participant hereby releases the Club, Photographers, its directors, officers, employees and assigns from and against any and all claims, demands, actions, causes of actions, suits, costs, expenses, liabilities and damages whatsoever that Guest/Participant may hereafter have in connection with the Images.

**Severability:** If any clause, phrase, provision or portion of this Agreement shall be determined to be invalid or unenforceable under applicable law or ordinance, such event shall not affect, impair or render invalid or unenforceable the remainder of this Agreement or any other clause, phrase, provision or portion hereof, nor shall it affect the applicability of any clause, provision or portion hereof to other persons or circumstances, and the Agreement shall be interpreted in accordance with such law or ordinance.
